## 2024 Summer Application for Non-Profits

Area non-profits are encouraged to take advantage of a free booth space at our Saturday summer market once per year. Make sure your plans for the space will qualify by reading through the details/rules below.

- Non-Profits are welcome to set-up an information booth at the market **when space is available**. You cannot collect signatures for a petition. Fund raising raffles are permitted. You are not permitted to sell anything. No soliciting or surveying by any political, religious, or other special cause groups or individuals is permitted at the market. No "hawking" or calling out to customers is allowed at our market. All your activities must take place in your booth space.
- Acceptance is based on the market manager's discretion and availability of space.
- The space is 10' x 10' and located in the lower lot - you provide your own tables, tent with weights and chairs.
- The market runs from 9:00am - 1:00pm. You need to staff your booth for that entire time. Your booth must be completely set up by 8:45am.
- There is no parking on the spot. You must unload materials, move your car down to vendor parking and return to set up your booth space. All helpers/staffers coming to staff your booth must also park down in vendor parking.
- The market is rain or shine. If you commit to a date, you are expected to be present. Emergencies will happen, but please give us notice of being absent as soon as possible. Empty spaces reflect negatively on the market. If you are a no-show, you will not be allowed to participate later.
- The market's rules & regulations sheet is attached for reference. **Keep this page for your records. Send in the second application page only.**
